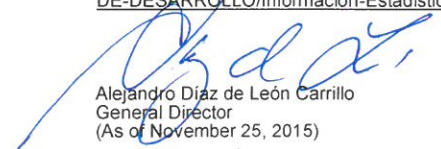

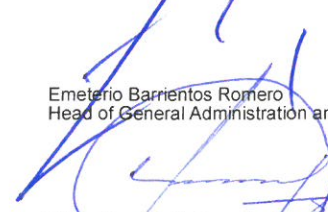

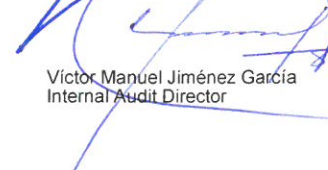
These consolidated statements of cash flows were approved by the Board of Directors under the responsibility of the undersigned officers.
